These questions will be explored in greater depth in the IDI, and participant responses can be expanded on that instrument.
1d	This response option is meant to capture any concerns the participant may have about storing the Wisebag in her house (eg safety, privacy)
1f	If the participant describes a concern that is not listed in the response options, the 'other concerns experienced (specify)' should be completed and a description written clearly in the space provided
